Staff will review the July discussion regarding opportunities leading to a Regents diploma, present some current instructional practices in New York, and share the plan to seek input from the field for possible revisions.

Potential Goals

The following are key goals for potential changes to the diploma requirements:

- Maintain rigorous graduation requirements while preparing students for 21st-century postsecondary options
 - Baccalaureate Programs in STEM, Humanities, Arts etc.
 - Technical degree programs
 - Career training certificate programs
 - Adult Education programs leading to certifications
 - Proprietary school programs
 - Military Service
 - Employment
- Offer more flexibility in completing credit requirements related to pathway choice and student interest.
- Expand external certification assessment options.
- Allow students to demonstrate proficiency in multiple ways.

Key Considerations

The following questions should be carefully considered as we move toward any change in requirements for a New York State diploma:

- How do we ensure that all students, including students with disabilities and English language learners, are able to access rigorous coursework?
- Should students have the opportunity to demonstrate proficiency in a specific area for graduation through a district-designed, standards-based Capstone project?
